A Fiscal Year 2017-18 millage adopted on 09-11-17 by Ordinance 17-61.

The one mill levy for Debt Service was authorized by 89% affirmative vote of the electorate on 06-07-05 (Resolution #05-R39). Purpose of the election was to determine "whether or not the City should undertake the construction of the West Virginia Drive Transportation Corridor from US 1 to Interstate 95 and pay the cost thereof from not exceeding \$165,000,000. in bonds payable from ad valorem taxes sufficient to pay debt service on the Bonds levied on all taxable property in the City".

The City of Port St. Lucie was incorporated on April 27, 1961.

The first Ad Valorem Tax Millage was levied on the 1971 Tax Roll.

Millage rates listed above are ONLY for the City of Port St. Lucie, Florida.
